Building Maintenance Report – Steve Petty

- Steve has made many calls to the contractor for estimates on sidewalk repair and he is waiting for a return phone call
- Once the water truck is removed from the parking lot, residents can return to his/her parking space.

Treasurer's Report – Theresa Burns

- Currently expenditures for the fiscal year beginning July 1st through October 31, 2025 amount to \$101,929.58. The amount remaining for the fiscal year is \$370,083.97.

Management Report – Claire M. McClennan

- I spoke with Sean Killeen from the DPW this morning requesting an update on the well project. The piping has been completed, and they are now working on starting up the new well and chlorinating all the lines and equipment. This will take about a week, perhaps a few days longer due to the Thanksgiving holiday. Also, there will be some testing needed. Sean said by the end of next week the tanker truck should be removed. He also added that you will find the water significantly better in the coming days.
- I ordered the Christmas wreaths from the Boy Scouts. Carey will pick them up after Thanksgiving and hang them also.
- Ernie Bonos, the electrician, has been working on the post lights. It has been very tedious work. He would put the switch on for a light and Carey would check the next morning to see if it remained on. Unfortunately, this has proven to be unsuccessful. The break in the line is somewhere under the pavement leading to the dumpster and would require digging to find the broken wire. Ernie suggested it would be far more economical to put a flood light on the water treatment building. He plans to do this tomorrow.
- Grasshopper said they will be on site one morning next week doing some additional trimming of shrubs. I phoned and emailed him to get confirmation of snow removal from the cars as his crew has done in previous years. I am waiting for a reply. All the landscapers are busy with fall clean up!

- The surveillance system is now online with the police department. Carey installed signs (required by law) on the front and back areas of the buildings indicating that cameras are recording. This is a legal requirement.

The meeting adjourned at 3:18PM. The next meeting will be held on December 18, 2025.
